

Official Contest Rules

1. **No purchase is necessary / Membership is required to participate in the prize drawing.**
2. **Eligibility for Promotion:** Entries: as provided herein. Participation is limited to eligible persons who are 12 years or younger and U.S. residents. By submitting an entry, you agree to be bound by these Official Rules. The Promotion period begins and ends on April 30, 2025 and applies to entries actually received by the Credit Union during this period. The Promotion drawing will take place on May 1, 2025 at 11:00 a.m. Employees/Officials of the Credit Union, their immediate family members and any person residing in the employee's/official's household are not eligible. Members must be the primary account holder on an account in good standing to be eligible. Winner will be notified by the Credit Union. If any prize is unclaimed, an alternate winner will be chosen.
3. **Prizes:** The Credit Union will award four (4) ticket vouchers for any regular season home Altoona Curve baseball game valued at \$60.00. Winner must redeem Curve vouchers at a Peoples Natural Gas Field Ticket office for actual tickets. Vouchers expire September 15, 2025. Prize will be awarded to the winning Star Saver when we have received a completed prize disclosure release of information.
4. **Entries:** All eligible automatic entries will be entered in the drawing to win this prize by having an open Star Savers Share Account in good standing on the date of April 30, 2025. If there are multiple parties listed on an account, entry will be based on the first party named on the account in question regardless whether the account is a multiple party account. The prize will be awarded only if entrants comply with these Official Rules. No other cash or consideration will be paid. To claim the prize, the winner's parent/guardian must sign and return a release and an affidavit of eligibility and publicity release to the Credit Union at their nearest branch by May 10, 2025, or prizes will, in the Credit Union's discretion, be forfeited.
